### City Council replies

IN response to "Questions for Clover" ( Courier, October 31), the City takes the safety of residents and visitors extremely seriously. That's why we are working closely with the NSW Police Force and Roads and Maritime Services (RMS) to make all intersections as safe as possible.

We work closely with RMS on the routes and designs of all our cycleways. RMS is responsible for setting speed limits on all NSW roads, not the City of Sydney.

NSW Police Force requested in-formation about the specific mark-ings on the Bourke St cycleway at the intersection with Harmer St and this has been provided.

The triangular signs on Bourke St cycleway alert cyclists of the need for caution and to slow down in that area, much the same as a give way sign. They are part of a new intersection design that was introduced in liaison with RMS.

The City works hard to educate all road-users on the need to co-exist safely through its StreetShare program, which aims to help everyone who uses our streets – whether by car, bike or foot – to have a safe and enjoyable trip.

Bike-riders need to obey the road rules like every other user. This means stopping at red lights, giving way when required, providing clear signalling, and safe lane changing.

# Facts on the centre

"NEW centre open for fun" (Courier, October 31) states that the "controversial" Bondi Junction childcare centre "is three storeys high after residents opposed the original four-storey design". This is inaccurate.



There's another side to this childcare centre, writes Frank Cahill

First, the use of the site for childcare, which dates back to the mid-1980s, was never controversial, except that the site was purchased by council in the 1980s to expand Clementson Park. What was controversial was the height and bulk of the building and the failure of council to engage in early and meaningful consultation with residents most affected by the develop-ment. Council's own written policy in place at the time identified the need for proper consultation at the project formulation stage. This did not occur.
Second, notices issued by council

when the DA was exhibited correctly described the development as a three-storey childcare centre plus basement. This made it a four-level structure - a large underground basement extending from Lawson St to Clementson Park and three levels above ground. There was no reduction in the number of levels as

reported in the article.

This matter is now ancient history and I wish the staff and parents who will use the facility well. But as the neighbour immediately to the

south, it comes at a high cost to me through the loss of all winter sun to my north-facing rooms; substantial loss of light to those rooms because of the height and proximity of the building, stripping tens of thousands of dollars from the value of my property; higher energy costs and other unresolved issues including damage to my property from the demolition and construction works. I believe anyone in my situation would feel justifiably upset about the impact of this development for which council was both the applicant and the determining authority.
